A PIC is required to report when it has made expenditures totaling \$750 for the calendar year or received contributions totaling \$750 for the calendar year. Please see [§20A-11-802](#) for details on PIC disclosure filings.

A corporation is required to report when it has made expenditures totaling \$750 for the calendar year. Please see [§20A-11-701](#) and [§20A-11-702](#) for more details.

A corporation is not required to report expenditures made to an entity that is required to report with the Lieutenant Governor's Office on disclosures.utah.gov.

A labor organization is required to report when it has made political purpose or political issues expenditures that total at least \$750 during a calendar year. Please see [§20A-11-1502](#) for details on labor organization disclosure filings.

A county political party is required to file a Year End Report if it has made expenditures totaling \$750 or received contributions totaling \$750 for the calendar year. Please see [§20A-11-510](#) for details on county parties.

"Candidate" includes someone who begins receiving or spending money to bring about their nomination to public office.
