

State of Utah 2026 Financial Disclosure Dates

(Subject to change during 2026 legislative session)

*Seven business day requirement applies to candidates during the thirty calendar days before convention, the primary election, and the general election IF the candidate is being challenged by another candidate for the nomination/election.

**Officeholders who have not filed for candidacy in 2026 are only required to file a Year End summary report and therefore are not required to file interim reports by their respective deadlines. Interim reports must all be filed by the end of the year as all reports make up the required Year End summary report (Jan 2026 – Dec 2026).

“Candidate” includes someone who begins receiving or spending money to bring about their nomination to public office. If you begin receiving contributions or making expenditures, you are required to report with our office.

A PAC is required to report when it has made expenditures totaling \$750 for the calendar year or received contributions totaling \$750 for the calendar year. Please see [§20A-11-602](#) for details on PAC disclosure filings.

A PIC is required to report when it has made expenditures totaling \$750 for the calendar year or received contributions totaling \$750 for the calendar year. Please see [§20A-11-802](#) for details on PIC disclosure filings.

A corporation is required to report when it has made expenditures totaling \$750 for the calendar year. Please see [§20A-11-701](#) and [§20A-11-702](#) for more details.

A corporation is not required to report expenditures made to an entity that is required to report with the Lieutenant Governor’s Office on disclosures.utah.gov.

All reports must be filed no later than 11:59 p.m. on the day of the deadline.
